President's Message

What a truly exciting time it is to be leading FSGA. There are many informational updates and recent news to share. Recently, two actions took place in our State Legislature. Rep. Passidomo's HB5 passed officially through both the House & Senate bodies, was fast tracked, and has made it's way to the Governor's desk awaiting signature into law. If you recall HB5 dealt primarily with the ETG and Wheel issues. Senator Detert's SB1226 died on the floor of the State Senate due to the early adjourning of the State House of Representatives. This bills death couldn't have been better news for all guardians. SB1226 basically dealt with establishing an Office of Public & Professional Guardians. If successful SB1226 would have meant many changes to the current Statewide Public Guardianship Office in the Dept. of Elder Affairs as well as requiring "licensing" of all Professional Guardians. I am thankful to the House of Representatives for their early session walkout as by this action FSGA has been afforded a short time for study and development of criteria relating to licensing of Professional Guardians. I believe licensing will be the future issue for Professional Guardians to deal with. FSGA supports the licensing effort and is committed to offering input for moving this idea forward to reality. In this vein, as FSGA President, I recently established an Ad hoc Licensing Study Committee to execute the association's role as a stakeholder in this process. The Licensing Committee is made up of representatives from a cross section of community member groups. Among participating members are the FSGA Board of Directors, RPPTL, Elder Law Section, Clerk of Courts, Fiduciaries, and FSGA Legislative Committee representation. The committees end goal is to effectively study, review, develop, and define educational requirements establishing components necessary to address the criteria of licensing. Guardianship in Florida changes loom large before us as the profession becomes more regulated with the switch of focus from "certification" to "licensing". FSGA must continue to press forward through all avenues available, in all regions of the State, offering input and ideas concerning the guardianship processes. As individuals we guardians tend to be a strong lot. Collectively we are not only strong but carry the ability to wield great sway in the future of our profession. I've encouraged all Chapter Presidents to consider hosting an advocacy gathering at their local levels, be it a BBQ or Cocktail Hour event, in order to meet & greet our elected officials in the hope of engaging in open dialogue to voice our concerns, offer our ideas, and identify common goals. Senator Detert, referred to Professional Guardians as "cockroaches". While one might presume this reference carries only a derogatory meaning lest we forget "cockroaches" have been around for 40-50 million years, adapting to ever changing circumstances, surviving when other species were destroyed and serving a greater purpose in the chain of life on earth. Not unlike guardians who tirelessly act to provide care, dignity, and life quality to those vulnerable and less fortunate among us.

The Florida clerks want your feedback, questions and comments about the issues and problems affecting the ethical and advocative services provided to persons under guardianship by guardians, attorneys and all other service providers. Please give your honest and candid feedback on the following questions. The information you provide will be used to develop a value-added Clerk's plenary panel session at the FSGA Conference on July 24th.

Background: The 67 elected clerks of the court throughout Florida have the statutory duty to audit and investigate guardianship reports and advise the court to its findings. Based on "best practices" that were developed by the clerk's association, legislation was codified in 2014 and 2015 giving the clerks the ability to perform greatly enhanced audits and obtain documents from guardians and non-parties. The clerks role in Florida Guardianship Law is vital and serves as a "check" and "balance" to the legal system. The clerks are not interested parties and have no stake in the outcome of any guardianship proceeding. The clerks are independent and objective which are hallmarks of professional auditing and investigating. Currently, there are approximately 20-25 counties performing enhanced guardianship auditing; constituting 35-45 percent of guardianship cases throughout Florida. In the coming months, more counties will be implementing enhanced guardianship auditing programs.





Legislation News

Legislative Committee Report

On May 13, 2015 the Legislative Committee of FSGA held it's monthly meeting. Discussion centered around the recent death of SB1226 related to establishing an Office of Public & Professional Guardians and Licensing requirements. It was noted HB5 addressing the ETG & Wheel issues was on the Governor's desk awaiting signature to become law. SB366 & SB318 did not make it out of the Senate. HB1225, the House counterpart to SB1226 also did not make it through session. Outline of planning for moving forward efforts of advocacy were addressed. Among idea topics shared were local Chapter hosting grassroots events such as BBQ or Cocktail receptions offering the opportunity to engage in sharing constructive communication with political leaders, individuals scheduling meetings with Legislative Representatives, creation of an FSGA Blog, creation of a committee comprised of various stakeholders tasked with studying and development of criteria addressing the licensing issue.

It was noted change is most effective when it is done with deliberate calm, void of the emotions of anger, fright, fight, and grief. This year Legislatively has been challenging and an exercise in patience and wisdom where calm, self assured, confidence has played well as the associations response. Nothing worth having is ever easy. Our struggle isn't over however, we've been afforded a little window of time in order to rally together, regroup, and define our profession going forward. If you've yet to become involved I urge you to get in the game and join us.

HB5 establishes new law relating to Emergency Temporary Guardians with prohibitions on ETG's being able to continue serving as Permanent Guardian. HB5 also contains focuses on the "wheel" concept. 
Auto Warranty Notices Confuse Consumers

This is one of the most annoying and deceptive marketing campaigns I have seen recently. It uses postcards, letters, and phone calls to sell outrageously priced extended automobile warranties to unsuspecting customers. The important-looking postcards/letters aren't quite a scam, although some consumers refer to them as such. It's actually a solicitation from a company that sells extended service or car warranty insurance on behalf of other companies. And the truth is, your car's warranty may be far from expiring!

There is usually an eye-catching warning on the card to get you to call their toll-free number. You're likely to hear high-pressure sales tactics and demands for a down payment and personal financial information before you're given details about the service contract. Never provide financial or other sensitive information like your bank account, credit card, social security or Driver's License numbers, as this information can be used to defraud unsuspecting consumers.

If you have questions about your vehicle's warranty, check your owner's manual, call the dealer who sold you the car, or contact the vehicle manufacturer. It's better to be safe than sorry!



A Note on Charity Scams

Charity scams take advantage of people's generosity by pretending to be a real charity in order to take your money. Scammers may solicit donations in different ways—by phone, over the internet, and in person. Do not judge a charity solely on an impressive sounding name as many organizations have names similar to well-known charities.

All charities soliciting within the state of Florida are required to register and file financial information with the Florida Department of Agriculture and Consumer Services. Before donating, you can request written literature and a copy of the charity's financial report. If they do not provide you with the information you request, you may want to think twice about donating!

To verify if a charity is registered, you can call 1-800-HELP-FLA (435-7352). Protect yourself by knowing who you are donating to. Never give out your personal information over the phone unless you initiated the call and the phone number is from a trusted source.

Unoccupied Vacant Homes!

Placing your ward permanently into a nursing home or other living arrangements outside of their home changes the status of the home for insurance purposes (if the home remains unoccupied). What you may not realize, is that sending your ward into what may be a temporary situation to a nursing home for physical therapy to recuperate from surgery (as an example) may place your ward's policy in jeopardy of cancellation for the very same reason. Almost all Florida homeowner's insurance companies define a home left vacant or unoccupied for more than 30 days, as "VACANT" or "UNOCCUPIED" and will cancel a regular homeowner's policy and/or deny a claim.

A cancellation notice of the homeowner's policy could happen as soon as the insurance company is made aware of the occupancy change, and worst case scenario, at the time of a claim. Of course, at that time it's too late to purchase the proper coverage, Vacant Home or Property Insurance.

Contrary to popular belief, Vacant Property Insurance isn't difficult to get for your ward. It can be more expensive than a regular homeowner's policy, and does not have the same coverage. Usually these policies do not cover contents of the home, and coverage for "riots or civil commotion" needs to be added as an endorsement when it's available. Vacant Home insurance is available in our Florida market place. Twelve month policies do exist that can be cancelled at the 3 month mark or after

(if the home is sold or the ward permanently returns to the dwelling). With this type of policy you're not locking your guardianship into a 12 month minimum premium.

It costs more, why? The reason that insurance companies have higher premiums for these policies is a direct result of the increased risks in an unoccupied or vacant home. Even for something like a water leak from a toilet, in a home that's occupied, is usually realized immediately, or when the owner comes home from work. In a vacant home, the leak may not be discovered until water is found running out the front door and is noticed by a neighbor! Other risks like vandalism and squatters abound with vacant homes, even in "nice" neighborhoods.

Bottom line: Consult with the agent for the current homeowner's policy to review the specific policy's rules about vacancy and unoccupied homes. Find the right insurance agent that will write the appropriate coverage for the ward's vacant home. Protect the asset.
